LIHEAP Heating Assistance

LAST CHANCE NOTICE: Utility bill assistance is available ONLY if you HAVE NOT received assistance since November 2018.

Tallatoona's LIHEAP program has funding available to assist with the utility used to heat your home. Families who qualify will receive either \$310.00 or \$350.00 toward their utility bill (primary heating source); it is NOT necessary that your bill be in disconnection status to receive assistance. If you HAVE NOT received assistance this winter season which began November 1, 2018, an appointment can be scheduled online at www.tallatoonacap.org and click the Book Now button or by calling the appointment line. Assistance is available 1 time per program year (November 2018 - May 2019). **Duplicate applications will be denied.**

An appointment for heating assistance does not guarantee processing or payment. **Approvals and payments are made when and if funds are received. Please continue to pay on your bill.**

Please bring the following documents to your heating assistance appointment:

- *Driver's license or state issued photo ID
- *Original social security cards for **EVERYONE** living in the home
- *Proof of citizenship or immigration status; driver's license, US military ID, US passport or card, state issued photo ID, US permanent resident card, alien registration card, employment authorization document, certificate of citizenship are all acceptable documents as proof of citizenship
- *Most current **heating bill** (bill **MUST** be dated within 30 days)
- *If your home is heated with natural gas, kerosene, propane, or wood you **MUST bring both your heating bill and electric bill to the appointment.**
- *Proof of income for the last 30 days for **everyone** 18 years or older living in the home; income includes but is not limited to, alimony, child support, disability, pension, rental income, retirement, social security, unemployment, wages from work, wages from self employment, and worker's compensation
- *If there is someone 18 or older living in the home who has zero income, they **MUST** come to the appointment

Tallatoona CANNOT obtain the information above for you at the appointment; please be prepared with this information or your appointment will be rescheduled.
